## ELIGIBILITY

Works must be current. Original works of art only (no reproductions). Entrants over the age of 18. Accepted art must be HAND DELIVERED. All mediums, including photography, will be accepted with the following parameters:

**2-D Works:** Wall hung work must not exceed 40" framed in either direction. Wall hung work must be wired and ready for hanging.

**3-D Works:** Sculptural works must not exceed 30" w x 30" d x 72" h including the pedestal. All works must weigh less than 150 lbs. All sculptural works must be either freestanding or include a sturdy pedestal.

**Video Works:** Artist must supply all equipment (ie. Monitors, DVD players, etc) for any video works, if selected.

**Installations:** Due to space constraints, installations are limited to the same size restrictions as 3-D works. Installations may NOT alter the walls or floors of the gallery beyond hanging hooks.

## ENTRY FEE

The non-refundable ENTRY FEE is \$25 for up to two artworks. Checks should be made payable to the:

## ENTRY FORMAT

Entries must be dropped off between hours of 9-11 am on Saturday September 26th. Pick up same day after 4pm. Library closes at 5pm.

## NOTIFICATION

All accepted artists will be notified by email or phone. Once accepted, artist will be asked to supply a current CV and artist's statement for inclusion in a gallery binder.

## SALES

The Friends of the Fairfield Public Library will retain a 25% commission for works sold during the exhibition. Sold works will remain in the exhibition until the end of the exhibition. Artists will be paid no later than 30 days after the close of the exhibition.

## INSURANCE

The Friends of the Fairfield Public Library insures accepted artwork for up to \$1000 of value as determined by an appraisal or proven history of sales.

## AGREEMENT

By submitting your work to this exhibition, all artists agree to allow reproductions of their digital files and/or photographs taken of their art for educational, publicity, and archival purposes.
